

As per provision of section 65(4) of Maharashtra University of Health Sciences Act 1998, I am directed to inform you that, on the basis of Local Inquiry Committee report and Circulatory permission from Academic Council, the Hon'ble Vice Chancellor is pleased to grant the First Time Affiliation to Vasant Dada Patil Ayurved Medical College Institute of Yoga, South Shivaji Nagar, Sangli-Miraj Road, Opposite Income Tax Office, Miraj Road, Tal. Miraj, Dist. Sangli (Maharashtra) for the Academic Year 2021-22, for Increase in Intake Capacity from 40 to 60 (Including EWS 50 to 75) seats of B.A.M.S. (UG) course.

However, the affiliation is subject to the following conditions: -

- 1) Fulfilment of norms and conditions laid down by Central Council of Indian Medicine / National Commission for Indian System of Medicine, (NCISM) and Govt. of India.
- 2) Rules and Regulations made by the Govt. and the University, as amended from time to time, will be binding on the College.
- 3) The college should obtain approval / recognition for teachers from Maharashtra University of Health Sciences, Nashik.

- 5) The college should obtain approval of fee schedule for the admission of the students from the fee Regulating Authority, Mumbai.
- 6) This First Time Affiliation to increase in intake capacity as per Central Govt. & Govt. Resolution shall be from **40 to 60** (Including EWS **50 to 75) seats** of B.A.M.S. (UG) course is valid for Academic Year 2021–22 only.

7) The next batch of students shall not be admitted unless Continuation of Affiliation of MUHS, is obtained by college / Institute.

8) Bank Guarantee should be submitted within a period of issuance of this letter to the University.

Grant of conditional Permission for 50 seats (including EWS) in UG (BAMS) course for the academic session 2021-22 and Grant of Letter of Permission to Vasantdada Patil Ayurvedic Medical College, South Shivaji Nagar, Sangli Miraj Road, Sangli-416416, Maharashtra (Inst. ID AYU0146) from the academic session 2021-22 to increase in intake capacity from existing 40 seats to 60 seats (50 to 75 seats including EWS) in UG (BAMS) course under section 28/29 of NCISM Act, 2020 and relevant regulations thereunder.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provisions of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-section (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) has been dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government notified that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021. In view of the above the Central Government constituted the Autonomous Boards with effect from 11th June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

Therefore, I am directed to refer to your application vide dated ref. no. 2. 1234/2020-21 dated 31.08.2020 (received on 07.09.2020) forwarded by GOI vide letter No. L-14013/14/2020-EP (1) Dated 04.11.2020 on the subject cited above and to say that physical verification of available facilities of teaching and practical training to increase the intake capacity in existing UG (BAMS) Course from 50 to 60 seats from the academic session 2021-22_could not be carried out in view of present COVID-19 pandemic situation as well as letter issued by M/o Ayush, Govt. of India vide no. L.14011/3/2020-EP-1 dated 26.03.2021 and 15.04.2021 in this regard as per policy, in respect of proposals for increase intake in UG seats under same slab i.e. 40 to 60 or 50 to 60 seats from existing ASU colleges, the recommendation for LOI and LOP may be made on the basis of Part-1 of proforma of inspection of college. Therefore, as per Part-I visitation proforma submitted by Vasantdada Patil Ayurvedic Medical College, South Shivaji Nagar, Sangli Miraj Road, Sangli-416416, Maharashtra as well as indemnity bond, affidavit & details of teaching, non-teaching and hospital staff

submitted by the said college were examined and vide Medical Assessment and rating Board letter ref. no 3-3/2021-Ay (07) dated 23.08.2021, Letter of Intent (LoI) has been issued to you for increase the intake capacity in existing UG (BAMS) Course from 50 to 60 seats from the academic session 2021-22, on the basis of proposal received from M/o AYUSH. Later It has been observed that earlier sanctioned intake capacity of your college is for 40 seats in UG (BAMS) course. Therefore, LOI issued to you vide Commission's letter dated 23.08.2021 was withdrawn and an opportunity to submit the FORM-3 (Application for permission to increase the admission capacity), No objection certificate from state Govt. and Consent of affiliation from concerned University to increase the intake capacity in existing UG (BAMS) Course from 40 to 60 seats instead of 50 to 60 seats from the academic session 2021-22 within 07 days was given to you.

- 3. Further your submission vide ref no. VPAMC/384-39/2021-22 dated 02.09.2021 was placed before Commission in its 05th meeting held on 09.09.2021 and Commission discussed the matter and directed to issue Letter of Intent for increase in intake in UG BAMS Course from 40 Seats to 60 Seats from the academic session 2021-22, as Government of Maharashtra has issued No Objection Certificate dated 01.09.2021 for increase in intake from 40 Seats to 60 Seats.
- 4. Accordingly, vide Medical Assessmen and rating Board letter ref. 3-3/2021-Ay.(7). Dated 04.10.2021, LOI (letter of Intent) has been issued to your college for increase the intake capacity in existing UG (BAMS) Course from 40 to 60 seats from the academic session 2021-22.
- 5. Further vide commission letter ref no. 3-3/2021-Ay.(7). dated 11.10.2021 letter has been sent to the college to furnish fixed security deposit worth rupees 25 lakhs in favour of National Commission fund for Indian system of Medicine, in response of the same college has furnished the fixed security deposit in favour of the National Commission fund for Indian system of Medicine through UTR no. SVCBH21285001242 dated 14.10.2021 of 25 lakhs transferred by Canara Bank (for a period of five years).
- 6. Further, in view of above, the college has been assessed on the basis of Relaxation policy issued by the Ministry of AYUSH and on examining in terms of Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the NCISM Act, 2020 and relevant regulations thereunder, it is found that the College is fulfilling notified and approved criteria for increase in intake capacity for existing UG (BAMS) Course & Granting Conditional Permission for UG (BAMS) course for A.Y. 2021-22.
- 7. Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM) to grant conditional permission to the Vasantdada Patil Ayurvedic Medical College, South Shivaji Nagar, Sangli Miraj Road, Sangli-416416, Maharashtra (Inst. ID AYU0146) for 50 seats (including EWS) in UG (BAMS) course for the academic session 2021-22 and Grant of Letter of Permission to increase in intake capacity from existing 40 seats to 60 seats (50 to 75 seats including EWS) in UG (BAMS) course under section 28/29 of NCISM Act, 2020 and relevant regulations thereunder, subject to following conditions:
 - The conditions as specified in the Undertaking/Indemnity bond submitted by the college.
- II. The college shall submit an undertaking in form of affidavit duly notarized within one month from the date of issue of the letter, explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying fee same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
- 8. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 75 UG (BAMS) seats (including EWS) shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2021-

22 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.

Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.

- Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- The following requirements should be fulfilled by the college by 31st December, 2021 to get permission for the session 2022-23:
 - all the requirements of Minimum Standard of infrastructure and teaching & (i) training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;

all the requirements of the Indian Medicine Central Council (Minimum (ii) Standards of Education in Indian Medicine) Amendment Regulations, 2016

(for Ayurveda);

- all the requirements under the provisions of the NCISM Act, 2020 and (iii) relevant Regulations made thereunder should be fulfilled in toto;
- This permission for increase in intake capacity in existing UG (BAMS) from 40 to 60 seats as stated above for the first admitted batch of 2020-21 session, will be valid till such time as the first batch of students admitted against these courses appear for the first final examination of the said courses and at that time, the College authorities may take up the matter for recognition of the qualifications under Section 35 of the NCISM Act, 2020.
- The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission matter from the academic session 2022-23.
