#### MEMORANDUM OF UNDERSTANDING

#### APPASAHEB BIRNALE COLLEGE OF PHARMACY, SANGLI.

#### 1) OBJECTIVES :-

The general objective of this Memorandum of Understanding (MOU) is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve to enhance the intellectual life and cultural development on both campuses as well as to promote and encourage students for research and academic activities. Both the institution have agreed that in support of their mutual interests in the field of education and research.

#### 2) <u>Technical Areas of Collaboration</u>:-

Physiotherapy institution will promote the exchange of students for Department Library Facility and will abide by all regulations, policies and procedure of their institution regarding the disclosing and handling of intellectual property, technologies, and confidential information that may arise under this MOU.

#### 3) Proposed Modes of Collaboration :-

Collaboration with College of Pharmacy Library for Library Facility & Research facility for providing interdisciplinary knowledge. A specific plan will be worked out by institutes depending upon availability of resources and facilities & resources availed at VPAMC Sangli eg. (Library, Pharmacy etc.)

#### 4) Terms and conditions:-

Both institutes agree to help the research work including physicochemical analysis for their institutional work as per the terms and conditions of institutions. This MOU may be amended, renewed and terminated by mutual written agreement of the institutions at any time. Either Institute shall have the right to terminate the MOU upon 60 days prior written notice to the other institute.

#### 5) <u>Confidentiality</u>:-

Institutes agree to hold in confidence all information data designed by the institutes as being confidential which obtain from either institute or created during the performance and will not disclose to same to any third party without written consent of the other institute.

#### 6) <u>Duration</u>:-

The period of the Memorandum of Understanding will be initially for a period of five years beginning from the academic year 2019-20 to 2024 and may be revised from time to time by mutual understanding between the parties duly recorded and signed on behalf of both the parties.

#### 7) Coordinators:-

Both institutes will designate persons who will have responsibility for co-ordination and implementation of this agreement.

#### 8) Intellectual property Rights:-

The intellectual property right (IPR) that arises as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two institutes.
